# EXTRAORDINARY GENERAL MEETING OF SHAREHOLDERS (EGMS)



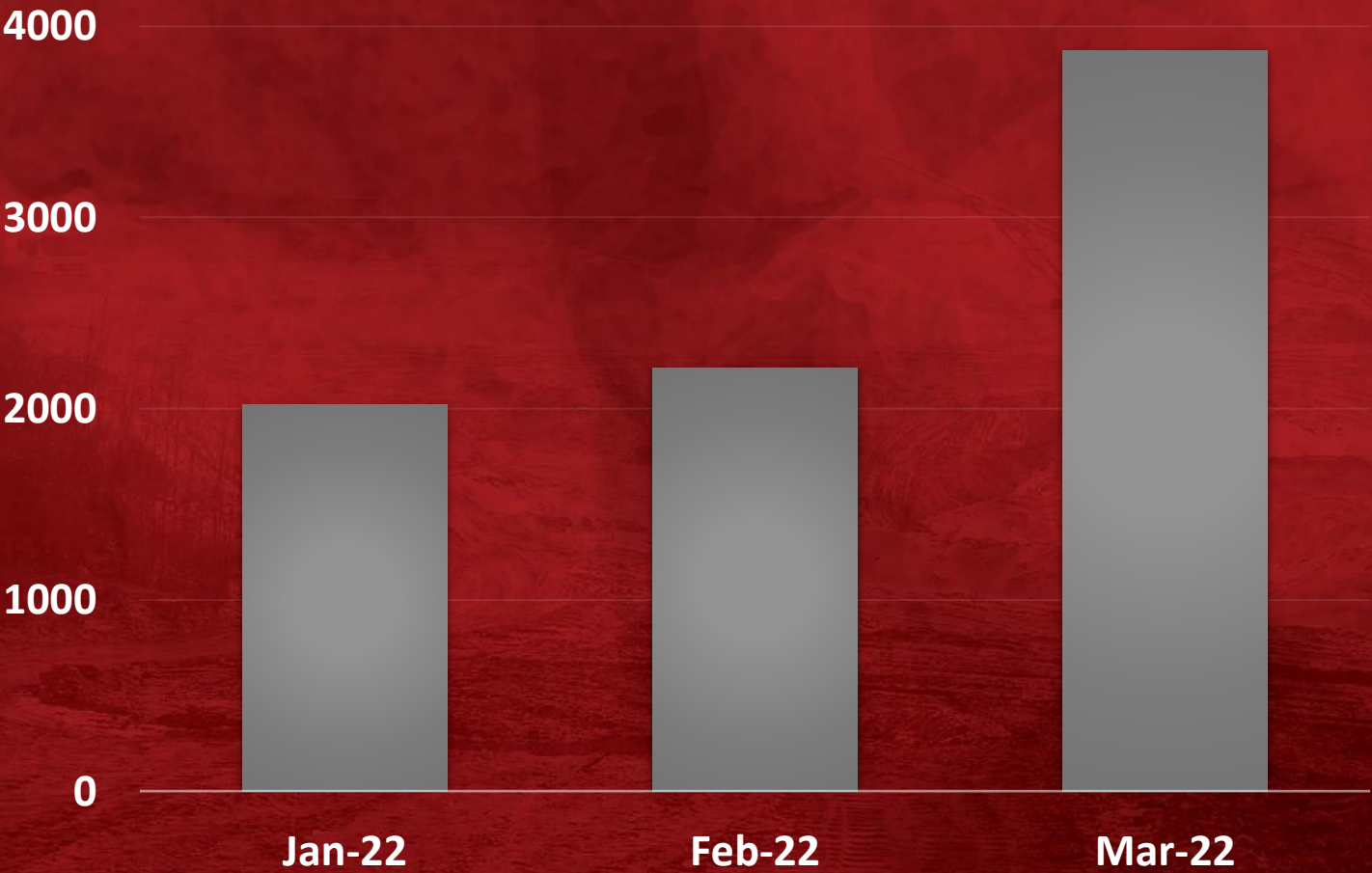

Shareholder Chart

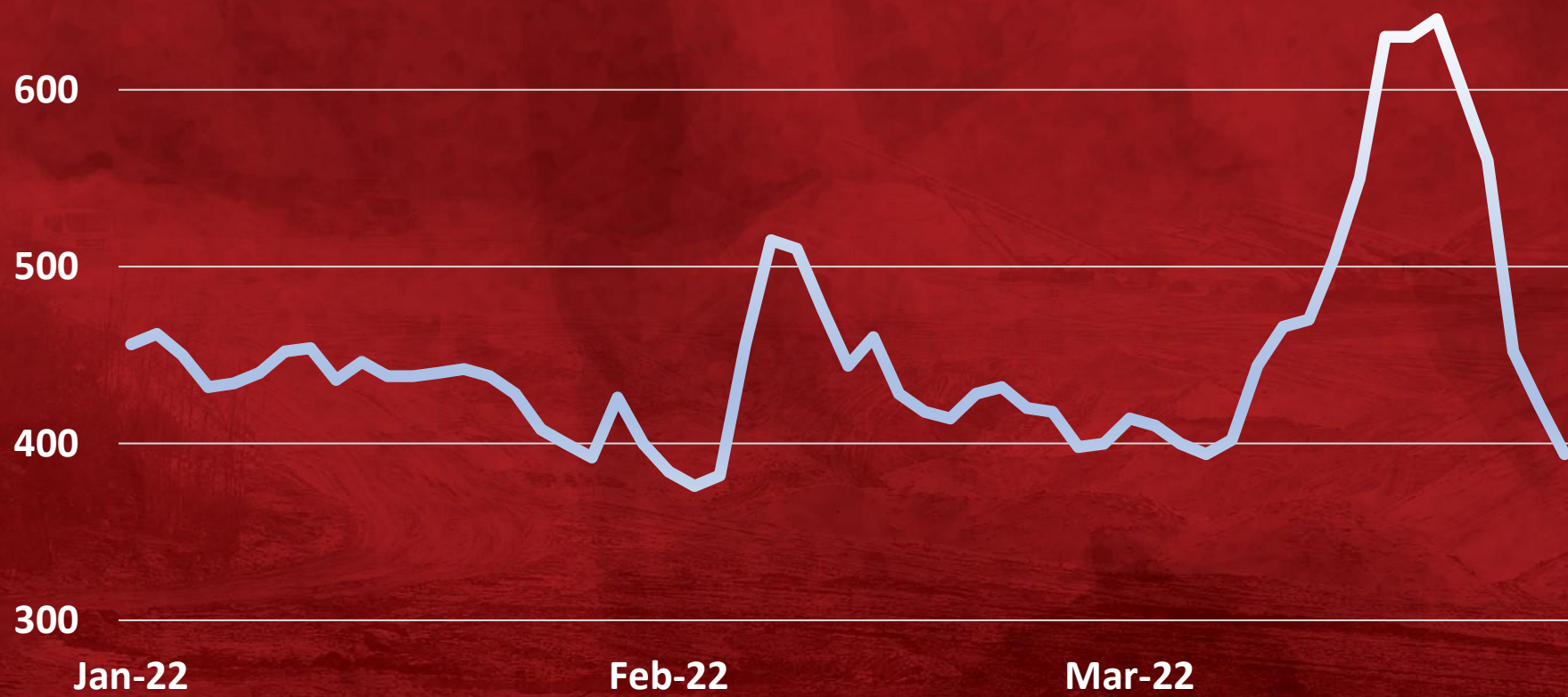




# STOCK PRICE CHART
