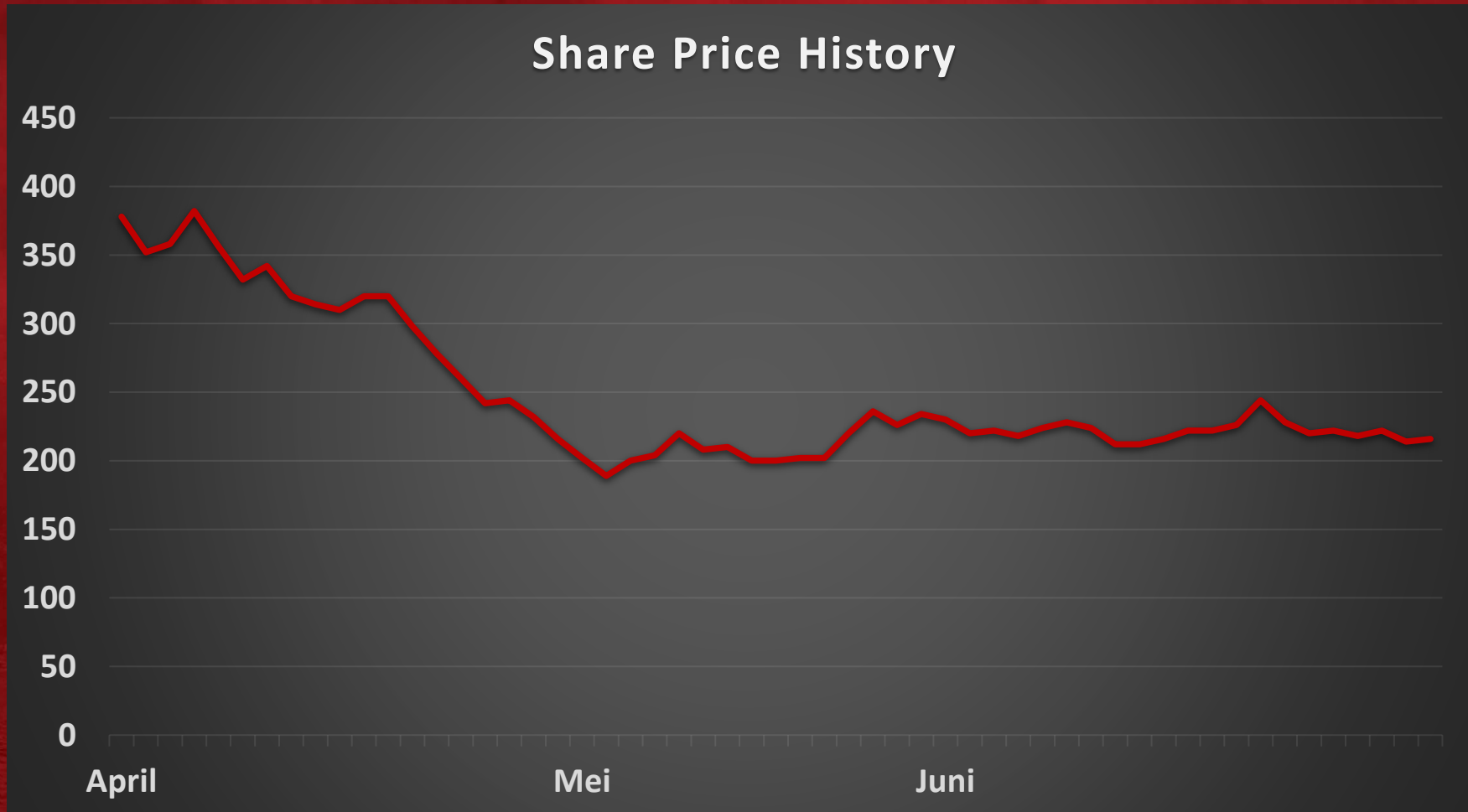


GENERAL MEETING OF SHAREHOLDERS, EXTRAORDINARY GENERAL MEETING OF SHAREHOLDERS

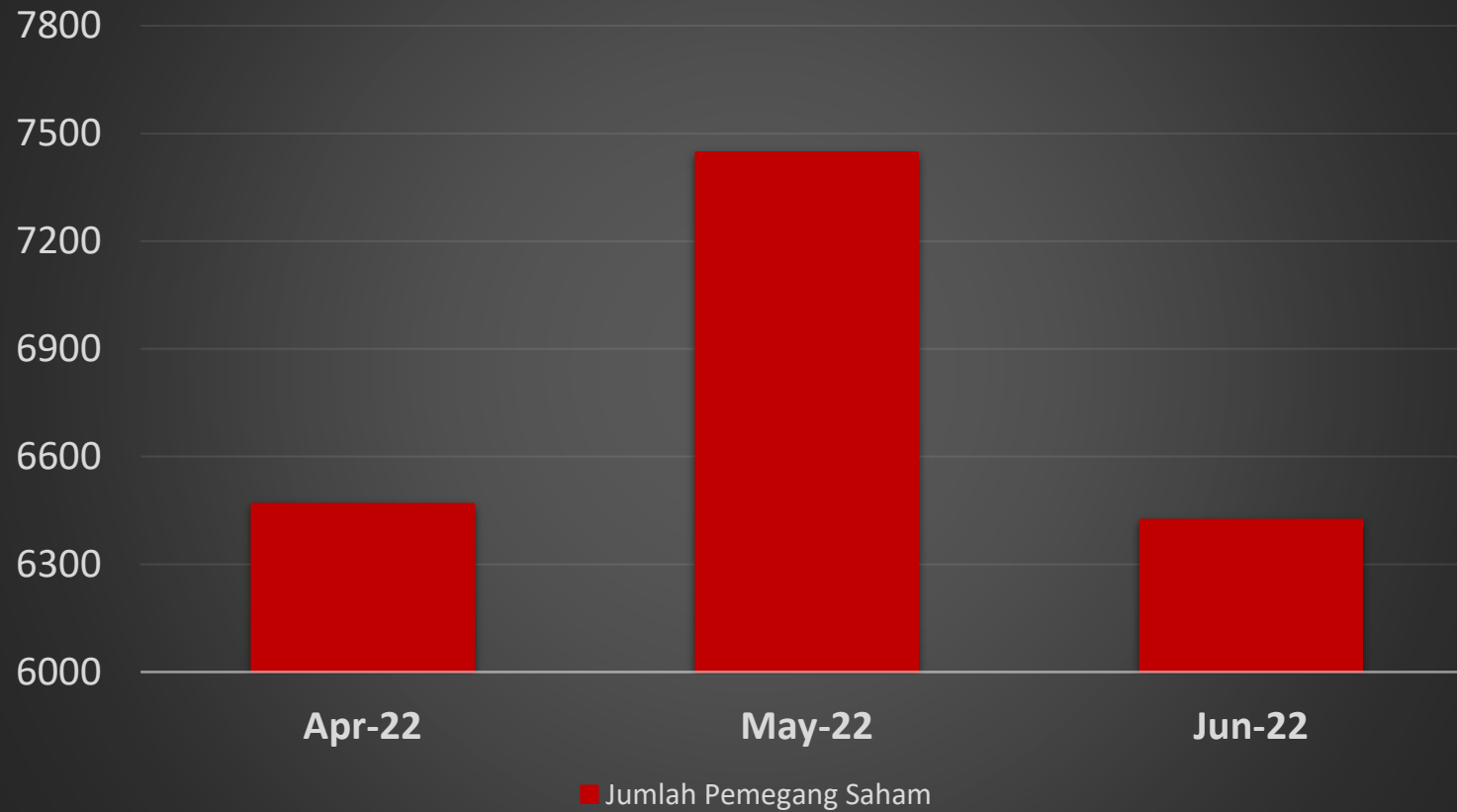
SHARE PRICE HISTORY
