In 2023, PT Transkon Jaya Tbk is ready to obtain three ISO certifications

Balikpapan, 22 May 2023, Currently, PT Transkon Jaya Tbk is in the process of obtaining three ISO certifications. The three ISO certifications are ISO 50001:2018 regarding Energy Management Systems, ISO 31000:2018 regarding Risk Implementation Guidelines, and ISO 26000:2018 regarding International Guidelines for Corporate Social Responsibility (CSR). On April 6, 2023, a kick-off meeting was held as the initial stage of the process of obtaining the three ISO certifications. In this kick-off meeting, the three ISO certifications were introduced to every employee representing each department.

There are several reasons for the company to obtain the three ISO certifications. The first, for ISO 50001:2018 Certification regarding Energy Management Systems, is motivated by PT Transkon Jaya Tbk's understanding of the company's operational activities, which have the potential to have a negative impact on the environment, such as Greenhouse Gas (GHG) emissions, waste generation, and the use of energy and water resources that can affect the balance of the ecosystem and the environment's carrying capacity for life. So, by owning ISO 50001:2018 Certification, the company is expected to have implemented international standards to manage energy more systematically, allowing the company to contribute more to reducing greenhouse gas emissions, environmental impacts, and other energy costs.

For the ISO 31000:2018 Certification regarding Risk Implementation Guidelines, it is motivated by the company's ever-increasing business scale, where the company is currently planning to carry out various kinds of business expansion and transformation. The company's goals are, of course, not free from risk. By implementing ISO 31000:2018, it is hoped that the company can increase the possibility of achieving its goals, identify opportunities and threats more effectively, and allocate and use resources to handle risks.

Regarding obtaining ISO 26001:2018 Certification regarding International Guidelines on Corporate Social Responsibility (CSR), obtaining this ISO certification was motivated by the increasingly complex and diverse CSR programs carried out by the company, both from internal

company parties and external parties. Seeing the possibility of increasing complexity of CSR activities that are currently taking place and will be planned for the future period, the company feels the need for international guidance, in this case, ISO 26000:2018, which will assist the company in carrying out CSR programs relevantly and effectively starting from the planning stage, implementation, monitoring, and evaluation of programs being implemented.

The three ISO certifications are targeted to be obtained by the end of 2023, which will add to the list of ISO certifications already held by PT Transkon Jaya Tbk, namely ISO 9001:2015 regarding Quality Management Systems, ISO 14001:2016 regarding Environmental Management Systems, ISO 45001:2016 concerning Occupational Health and Safety (K3) Management Systems, and ISO 37001:2016 concerning Anti-Bribery Management Systems.
